Report 1: Workshop on E-Filing and Taxation Held on 17th June 2025

Title: One day workshop on computerised accounting & E-filing (Semester VI)

Date: 17th June 2025

Objective:

To provide practical training on e-filing of taxes and to enhance students' understanding of taxation laws and digital compliance as part of the B.Com curriculum.

Overview:

On 17th June 2025, Harimohan Ghose College organized a dual-session workshop for the 119 students of Semester VI in the Smart Classroom. The focus of the workshops was on e-filing of taxes and general taxation concepts, which are vital components of the commerce curriculum. The session was led by Prof. Sayak Mitra, Assistant Professor at St. Xavier's College, and an expert in taxation and accounting practices.

The first session introduced students to the basics of income tax filing, the structure of the Income Tax Department portal, and key documentation needed for individuals and small businesses. The second session was more hands-on, demonstrating the step-by-step process of e-filing using live examples and simulated data.

- Clarification on common mistakes and how to avoid them
- Q&A session to resolve student doubts

- Boosted confidence in handling taxation tools and portals
